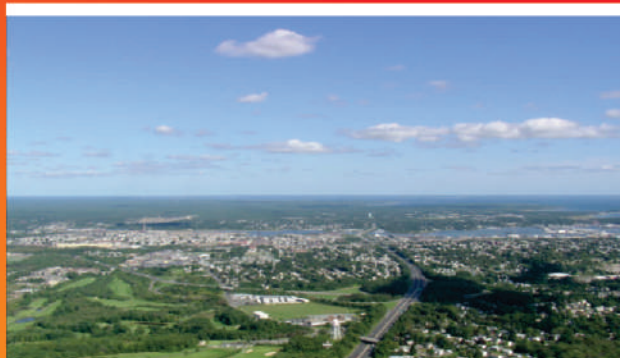

The government of South Sudan through its Ministry of Mining (MoM) encourages engagements of investment into exploration, development, mining, processing, reclamation and harmonizing of the mines.

South Sudan's incredible geological riches rank among the highest in the world and 90% of the country has not yet been explored for minerals and is the world's largest untapped area.

## RAMCIEL NEW CAPITAL CITY PROJECT

The new executive capital for South Sudan; Ramciel, was chosen by Dr. John Garang, the first president of Southern Sudan as future national capital because of its geographic position in the country and to make the seat of government more accessible. Ramciel is about 250 kilometres (155.343miles) north of Juba. Ramciel is suitable for large-scale construction of infrastructure for public institutions, investments, and the accommodation of diplomatic missions etc.

The rocky highlands of Ramciel can support a major and modern city if built there. The land in Ramciel is currently uninhabited and lacks basic infrastructure such as roads, water and electricity. The Comprehensive Master Plan development financed by the government of Morocco at the cost 3 million dollars and being carried out by South Korea; is ongoing to include demarcation of areas for key government installations, roads, markets and residential areas.

A lot more of physical and financial investment are heavily needed for a successful accomplishment of the project



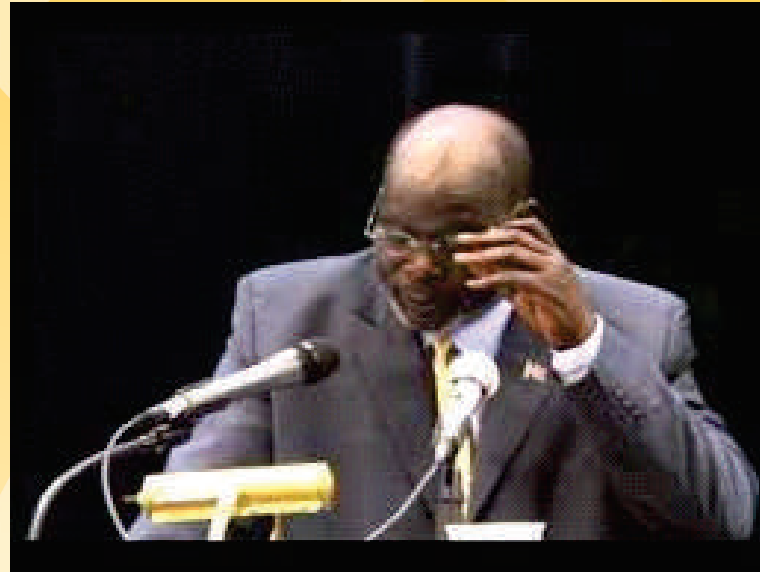

## FOUNDING OF SOUTH SUDAN

At midnight on 9 July 2011, South Sudan became an independent country under the name Republic of South Sudan. On 14 July 2011, South Sudan became the 193rd member state of the United Nations. On 28 July 2011, South Sudan joined the African Union as its 54th member state.

Dr. John Garang de Mabior was a Sudanese politician and leader. He led the Sudan People's Liberation Army during the Second Sudanese Civil War, and after a peace agreement, he briefly served as First Vice President of Sudan from July 9, 2005 until his death in a helicopter crash on July 30, 2005. He was a developmental economist by profession, and considered the single most influential person in the history of South Sudan. Salva Kiir Mayardit, his deputy, was sworn in as First Vice President of Sudan and President of the Government of Southern Sudan on August 11, 2005.



## PEACE CELEBRATION

Pope Francis, in the watch of Archbishop of Canterbury, Justin Welby - Leader of worldwide Anglican Communion, kissed the feet of South Sudan leaders after a two-day retreat at the Vatican and expressed the wish to ascertain the conditions for a possible visit to South Sudan as a sign of closeness to the population and of encouragement for the peace process.

Thousands of citizens gathered in Juba on 31st October 2018 to celebrate “dawn of peace; “Peace has come and it is here today to stay. “Uttered by President Salva Kiir Mayardit, were greeted with jubilation by a sea of thousands of rejoicing, sun-defying, peace-starved South Sudanese packed in the Freedom Square and Dr. John Garang de Mabior Mausoleum area in central Juba.



“I re-extend my invitation to Dr. Riek Machar to return home. I have completely forgiven him and he is no longer my opponent. I call upon all armed opposition to work with our army to continue to open corridors for freedom of movement and open up trade routes. We are not war mongers, we are peace loving people and we are a proud and dignified nation. “The presence of the opposition today is a strong testimony that war is ending”. The president stressed.

“To see parties that have previously been divided by violence coming together here in Juba, is a public sign of unity, sends a strong signal to the citizens of this country that you are genuinely committed to end the suffering and building durable peace,” David Shearer, Head of the United Nations Mission in South Sudan, remarked. “We will stand alongside the parties as they move forward in peace. We will use our resources and our presence across the country to support reconciliation and peace building,” he continued.

Riek Machar was grateful for the efforts made by the United Nations, the Security Council and others, reserved most of his appreciation for the essential steps taken by neighbouring Uganda, Kenya, Ethiopia and Sudan to push the revitalized agreement over the line.



“You have lost a lot of development time. It is very dangerous to use identity in politics, as is the case with tribalism,” Mr. Museveni commented, adding that “no more blood over political arguments” would be a good future policy.

Salva Kiir urged those in attendance to join him in “welcoming and congratulating Riek Machar and leaders of other opposition groups for coming here today”, and instructed the army and other security forces to immediately stop fighting and “let everybody move freely”.

Riek Machar and other opposition leaders were joined by Sahle-Work Zewde, president of Ethiopia, Omar al Bashir of Sudan, Uganda's Yoweri Museveni, Somalia's Mohamed Abdullahi, Egypt's Prime Minister Mostafa Madbouli and several other foreign dignitaries and officials.

Embrace peace, our economy will thrive again and Security will return to South Sudan; president Kiir said in a speech on occasion of celebrating six years of independence. The president also thanked opposition parties for their commitment to the peace agreement.

UN said in weeks not so long that the peace deal had seen a decrease in violence in South Sudan.
